- Booth price: \$40.00 (Non-profits); \$65.00 (Vendors). Booths will have (1) 8 ft table/vendor & 2 chairs. Vendor must supply any additional tables. Space size 10' x 8' ft. Booths are to remain open until closing time. Place large debris in outside dumpster, leaving premises in good condition.
- Payment & Application fee: Return application and payment by November 6, 2020.
- Tables must be covered with floor length tablecloths, supplied by Vendor, with no visible boxes showing. Bridgewood Farms will not provide tablecloths.
- **Check-in and set-up on Friday, December 4 starting at 8:00 am.** Vendor must be set up and ready for business by opening time on Saturday, December 5 by 9:30 am.
- Each Vendor is required to provide a door prize item to be given away during the Market. The door prize (value \$15) can be one of your products, NOT a discount for one of your products.
- 1 Box Lunch (includes sandwich/chips/cookie/drink) is provided per vendor; Additional lunches \$10
- Christmas activities: face painting, games/activities, arts/crafts and inflatables. Photos w/SANTA, poinsettias available; Hand-made ornaments from Giving Tree, Adopt-A-Bridgewood Farms Program, Purchase Raffle tickets and Donate canned food to Food Bank.
- Checks, Cash and Credit Cards accepted; Cash Apps/I-Phones (internet spotty).
- Bridgewood Farms must receive payment & application for your table to be reserved.
- If we CANCEL due to COVID-19 or not enough vendor interest, your money will be REFUNDED.
- We hope COVID-19 is under control in December to hold our event, but if not, we will notify all registered vendors ASAP of the need to cancel. If social distancing and masks use is required at the time of the event, Bridgewood Farms will require all vendors and shoppers to comply.
